State of the District

Supt. Klaehn updated the ongoing State of the District document with the Board.

Long-Range Financial Considerations

Discussion was held regarding some long-term needs and financial planning to meet those needs. Supt. Klaehn introduced a possible additional fund to be established for large cost, long-range needs.

Proposed 2011 Pay 2012 Levy Certification

Supt. Klaehn explained that passage of our operating referendum in November would not increase taxes; however, state activity would raise taxes. Should the referendum pass, the statement taxpayers would receive in the latter part of November will not reflect the passage of the referendum; however, their April tax statement would and, thus, be higher than the November statement and look like taxes increased due to passage of the operating referendum. Mr. Klaehn explained that, if the Board decided to adopt a maximum levy on this proposed levy certification now, it could be adjusted for data changes prior to the final levy certification.

A motion was made by Member Andring, seconded by Member Johnson and carried unanimously to adopt the Proposed 2011 Pay 2012 Levy Certification (Attachment A).
