Motion by Carlson, seconded by Kylo to support resolution that would move LP Football into District Midstate and/or Mid-Southeast and/or Southwest and the denial of the MSHSL putting LP Football into District South-Central. Voting was 6 for, 0 against.

Handicap parking discussion. Board recommendation is to add additional handicap parking spots on east side of school. Superintendent McNulty will appear at next Lester Prairie City Council Meeting and seek permission.
