### ELIGIBILITY



- RULE CHANGES FOR 2024-25
  - 18.6.0 A middle school student may participate at their resident public middle school if a program is not offered at a non-member school in which they attend
    - Support- 41 Opposed 12



# **ELIGIBILITY ISSUES**



- SEASON LIMITATIONS
  - $\circ~$  Check your timelines to align initial enrollment in  $7^{th}\,grade$ 
    - After entering or being eligible to enter the seventh-grade students shall have six consecutive years of interscholastic eligibility.
    - If a year is repeated, it must be based on a documented academic deficiency verified by the school principal
  - SCHOOL OF CHOICE TO SCHOOL OF CHOICE
    - Double Hardship- must also have a hardship for not returning to resident public school



# ELIGIBILITY ISSUES CONTINUED



- "1 HOP" SEPARATED OR DIVORCED PARENTS
  - $\circ$  Court approved legal separation or divorce
    - Timeline of the move relative to the move
    - Must meet all other conditions of eligibility
- WINDOW OF TRANSFER
  - $\circ$   $\,$  No corresponding change of residence necessary
    - Access one time between the natural break from Jr High and High School
    - If the receiving school declares 9<sup>th</sup> graders as HS athletes the break is between 8<sup>th</sup> and 9<sup>th</sup> grade



# ELIGIBILITY ISSUES CONTINUED



- FULL FAMILY UNIT MOVE
  - $\circ$   $\,$  Must fully vacate all occupancy of previous residence  $\,$
- SPORTS ACADEMY ATTENDANCE AND RETURN
  - $\circ~$  IF it was not a full family unit move, upon return, the student is subvarsity eligible only
    - After one calendar year return and re-establishing family unit, student is eligible for varsity
  - PRIVATE SCHOOL RADIUS 50 MILES
    - Any move within 50 miles of the original private school, athletic eligibility remains tied to the private school.

# **ELIGIBILITY TRANSFERS**



- Transfer Committee
  - 22-person committee assembled to evaluate Association's current rules regarding transfers and eligibility.
  - $\circ$   $\,$  Focus on two topics:
    - Verifying WIAA Eligibility rules specific to transfer align with current Washington State education goals and objectives such as mastery based learning
    - Determine if (and if so, how) WIAA eligibility rules may disproportionately impact students
  - The Committee has until October 11, 2024 to propose an amendment to the transfer and eligibility rules. Amendment then presented to WIAA's Rep Assembly at Winter Coalition in January 2025. From there, the amendment would move to rep assembly for voting in the Spring of 2025.
    To pass, 60% vote in favor (21-14)
