17.15.4.A Subvarsity teams may also schedule an additional contest if paired with the varsity Foundation contest, at no additional cost to the school.

17.15.4.A An additional dual meet in wrestling can be scheduled as a Foundation Game. *Will be available for scheduling next week at the same rate as a volleyball match - \$100.

Amendment proposals around the Gender Identity Policy

- Schools and districts submitting should conduct their own legal review if the language is compliant with WA State Laws
- WIAA will not conduct legal review on behalf of submitting schools

 - Transgender athletes would still have option under law
