1. Items from CIF

Brief review of items from Executive Council, Coordinating Council, CIF Board of Managers.

- a. Football Enrollment Factor
- Football enrollment factor proposal was approved. This vote was very close.
- It impacted four schools, only one from SDUSD, Lincoln moved to division one and kept Pt Loma in division two.
 - b. Continuation Schools
- Continuation school eligibility proposal was approved.
- Read the names of the schools who participate in the Multi-Campus Agreement.
- It is the site's decision to participate in the Multi-Campus Agreement.
 - c. CIF Fees Increase
- Handout was provided and reviewed.
- Fees will almost double within the next two years, an increase of almost \$22,000.
- There has not been an increase in about 10 years.
- Our office will cover the CIF fees as long as we continue to generate income from the gate recaps.
- It is critical that the Athletic Directors do not cancel sports and then we end up paying CIF for sports we don't have.
 - d. HSSOC Officials Fee Increase and Analysis
- Handout was provided and reviewed.
- The committee met and looked at all sections and looked for a medium.
- Over the next three years, there will be an increase in official's fees, this increase will impact school sites since sites are not receiving any more money.
- The Athletics Office is looking at different options to offset this expense.
- This may mean playing one less game to cover the cost of the fees increase or more fundraising.

3. Athletic Meeting Attendance

- a. 2018-19 SDCC pre and postseason coaches meeting attendance

- 4. 51st CSADA Conference in San Diego April 3-7, 2019
 - Roles, responsibilities and funds for SDUSD.
- All sixteen SDUSD high schools are registered and attending the CSADA conference.
- J. Babineau of Hoover High School is registered to attend the CSADA conference to represent all principals.
- The Athletics Department paid for the CSADA conference registration fee as long as the ADs committed to attend the conference Friday and Saturday.
- The school sites are responsible for covering the Friday substitute expense.
- 5. SDUSD Athletic Financial Information

Discussion of next steps and impacts for the following items.

- a. Fall SDCC tournament recaps
- The Fall San Diego City Conference tournament recap sheets were provided and reviewed for Cross Country, Girls Golf and Girls Tennis.
- All three tournaments were in the positive at the end of the tournament.
- Wrestling is the only tournament for the winter season.
 - b. Finance and the impacts of sports offered- SBB it has been updated with 2018-19 spring data from 1/29 coaches meeting
- Reminder to ensure that the sports being offered at schools are noted in SBBs.
- It is recommended to add sports now rather than try to get money later.
 - c. SDUSD athletics federal program monitoring (FPM)
- Auditors have access to all sites for athletics but focused on Hoover, Lincoln and Point Loma as a sampling.
- Thanks to the three schools for getting everything requested for the audit.
- Findings that are received in one school will apply to all schools.
 - d. SDUSD BSN agreement and data from the non-exclusive agreement
- Handout was provided and reviewed.
 - e. SDUSD ArbiterPay transition to issuing 1099s starting January 1st
- District Finance will no longer be processing the 1099s for ArbiterPay and has agreed to pay for the 1099 transaction fee.
- S. Seiders worked with ADs and Finance Clerks to turn on the service.
- S. Seiders will also provide guidance about how your site will receive reimbursement from District Finance for the minimal 1099 transaction fee.
- 6. Calendar and Schedules

Discussion of scheduling, calendars, and concerns for athletic seasons.

- a. Complexity and plan accordingly for basketball league schedules next year- league start before winter break
- Learned from all the issues that Saturday games caused.
- We will start winter leagues before break next year.
 - b. 2019-20 Physical Information and Free Physical Event at SDHS
- ADs and coaches were holding the line to ensure physicals covered students for the entire year.
- Free physicals for high school students and incoming 8th graders will be offered again this year.
- San Diego High will host the free student physical event on Saturday, June 1st.
- A flyer will be emailed and available on the Athletic website to help promote the event.
 - c. CIF Draft of Master Calendar for 2019-20
- A draft copy of the CIF Master Calendar for 2019-20 was shared and reviewed.
- The football start date has changed to July 30th, this will be the same start date for the next three years.
- 7. SDCC Spring Sports Team Offerings for 2018-19 Grid

Providing the grid that includes what spring coaches shared is being offered for 2018-19.

- a. FYI process for cancelling a team prior to or mid-season- Blue Book section 2.14.6
- Shared the process that has been consistently shared with ADs if you have a team that folds.
 - b. Conversations from SDCC and Fall Postseason Coaches Meeting- cancelling/forfeits
- Football had a lot of communication issues among coaches.
- Shared items of concern with football.
 - a. CIF ramifications vs. league ramifications
- Principals provided input and suggestions.
- S. Giusti wrote down their concerns and suggestions to take it back to CIF.

8. SDUSD NFHS Pixellot Cameras on Facilities

Updates and next steps.

- a. First Wave Complete: Madison, Mission Bay
- The first wave of camera installation is done.
 - b. Second Wave Status: Clairemont, Crawford, La Jolla, Mira Mesa, Patrick Henry, Point Loma, UC
- The district is being supportive in expediting the camera installation.
 - c. Third Wave Status: Hoover, Kearny, Lincoln, Morse, San Diego, Scripps Ranch, Serra
- The second wave of schools are still getting everything squared away regarding PPO and installation so we are not ready for the third wave yet.
 - d. Next steps
- Currently waiting on an update from PPO so we can work to finish 2nd wave and begin 3rd wave of schools.

- a. Athletic Periods during the school day
- Will be centrally reviewing master schedules next week before auditors arrive to ensure proper credentials and procedures are followed for athletic periods during the school day.
 - b. Multiple impacts and have school sites created a plan
- Minimized for this year based on fewer schools than expected.
- Practice cannot be held before school starts and practice time has to be when bused students can be accommodated.
- S. Giusti shared he has an ongoing list of concerns and was asked to share the list of issues with schools.
 - c. Which schools are piloting
- La Jolla was approved to pilot the late start schedule.
- S. Giusti was asked to participate in a Healthy Start Committee (late start).
- 12. SDUSD Facility Maintenance

Discussion of options for maintenance including use of District Rentals as funding source.

- a. Field Turf
- b. Track
- The Field Turf grooming schedule was emailed in December however an updated copy was emailed yesterday.
- Starting track grooming discussions for same type of program.
- Rentals money should be invested to maintain your athletic facilities.
- Seeking outside vendors that can contract to provide track service.
- Athletic Council shared the need for a routine maintenance schedule to be funded by facilities and not the sites.
