 - Shared that currently SDUSD is fan free.

10. SDUSD Trainers
Concerns and direction of the work by the Athletic Director.
- Shared that SDUSD contracts with UCSD for Athletic Trainers and the contract is set to expire at the end of June 2021.
 - Shared to work together as 3 schools still need trainers.

11. SDCC Schedules
Ron Lardizabal to provide an overview and review of multiple schedules discussions.
- Shared that Track & Field needs to have a league final for each of the leagues in order for athletes to qualify for CIF prelims.
 - The last meet that is scheduled on Thursday, May 27th is moving to Saturday, April 17th.
 - Each 3 leagues will have the finals on Friday, May 28th.
 - Shared to work with coaches and the visitors to find alternate dates if Saturdays do not work.
 - Shared that Badminton games are scheduled after spring break.
 - Badmintons games are currently scheduled on Mondays and Saturdays.
 - Shared that there are conflicts between boys’ basketball and volleyball due to sharing the gym.
 - Volleyball schedule has Eastern and Central Leagues scheduled to play on Tuesdays and Thursdays and City and Western Leagues to play on Wednesdays and Fridays.
 - Basketball games are on Tuesdays and Fridays. Possible solutions are to move volleyball games to Fridays since they did not have a season last year. Move to Mondays and Saturdays for Tuesday schedules for either basketball or volleyball or sites are responsible for making the changes if there are conflicts.
 - Varsity games can start at 3pm. Use the game change form if changes need to be made, if not, if there’s a conflict, it reverts back to the official schedule that is posted.
 - Discussion was held.
 - If schools only have Varsity teams, then the school can have volleyball and basketball games on Fridays.
 - Proposal vote A is to move basketball to Saturday and keep volleyball on Fridays, B is to move volleyball to Saturday
 - Schedule and C is for the sites to work out the conflict.
 - Majority of schools voted for C, for the sites to work out the conflict.
 - R. Lardizabal will inform ADs which sites have conflicts.
 - Shared to reach out to the Athletics Department, if sites do not agree.
