	Updates and information from the CIF San Diego Section.
	a. Updated CDPH guidance takeaways
•	Shared updates on competition, contests, double headers, spectators, observers and quad meets.
	b. Season 2 championships, logistics

- CIFSDS championships for Season 2 are still on.
- Shared that the State CIF is making decisions regarding state regional and state championships next week.
 Regional championships could take place later on June 25th and 26th.
- Reminder was shared that the schedule can be found in the CIF master calendar.
- Majority of the events will be held at high school venues and observers will be limited.
- Reminder was shared that the sports schedules must be posted into CIF home and the deadline is on Friday, April 23rd.
- Ranking system will go live on Tuesday, April 27th.
- As of now, championships are as scheduled on master calendar.
 - c. Are there sports where the results this year will impact the 2021-22 Power Rankings/team placements/Divisions
- Divisions will roll over to 2021-22 divisions placement for season 1 sports.
- Season 2 sports will depend on what the outcome looks like, not at the point to have enough data.
- Season 1 sports will not be counted for 2021-22, season 2 sports are on the table.
- CIF is hoping to make decisions for season 2 sports by June 1st.

- Master calendar for 2021-22 has been approved by the Board of Managers and posted on CIFSDS website.

- Schools will have to adjust accordingly for finals.

- 6. SDUSD 2021-22 Physicals

Concerns for timing of athletic physical completion, physicals timeline and impacts/monitoring/verification.

- a. Focus/planning on 2022-23
- Honor the current physical up until the expiration date.
- The goal for 2022-23 physical will be back to having students get their physical done after the certain date for the school year.
- Hoping to have the free physical event again for 2021-22 and will plan to have it for 2022-23.
- 7. SDUSD 2021-22 Football

Items of discussion regarding the season.

- a. Reconditioning
- Shared that the Legal Office is clarifying whether reconditioning is required for a calendar year, or if it's one season.
 - b. New purchase
- Shared that the aged out helmets will be replaced by the Athletics Office when they are turned over to the Athletics Office.
- Shared that without gates this year, school site funds may need to be used.
- Reminder was shared to ensure that there is an accurate report for each helmets at each site.
 - c. Chargers grant
- Shared that the Title I schools were eligible to apply for the Chargers grant to receive \$1,500.

Discussion of the 2019-20 policy and the 2020-21 policy with regards to success and accountability.

a. Tracking missed contests due to COVID cases

12. SDUSD Trainers (ATC)

Finishing off 2020-21 and planning for 2021-2022.

- Information was shared that the Athletics Office is looking into filling the vacant Athletic Trainers at some schools through temp agencies.
- Information was shared that a new contract may potentially be for the sites to get trainers for more hours per week and paid at a higher rate.

Status update on the 2021 tournaments (Badminton, Cross Country, Golf, Tennis, Swim & Dive, Track & Field and Wrestling).

- Shared the tournament directors for each sport.
- Shared updates:
 - Badminton HL (company) will sponsor the birds and the tournament director is contacting sites to host the tournaments.
 - Cross Country Did not have a traditional tournament.
 - Golf Girls' tournament will be in the week of May 17th and boys' tournament will be in the week of May 24th at Balboa at no cost.
 - Tennis The tournament director is looking for new ideas and venues.
 - Swim & Dive No City Conference tournament was held.
 - Track & Field Tournaments are on hold.
 - Wrestling No clear plans at this time.

15. SDCC Season 2 Impacts

Review and discuss potential impacts.

- a. Baseball Central League
- Shared that there was a recommendation made to put Central and City leagues together so if one school drops out, we still have enough schools to compete in the league.
 - b. LAX proposal
- Shared that there was a proposal to allow schools to play 7v7 if schools could not form a full team, however it would not work within CIF bylaws while allowing the team to compete for a CIF Championship.
 - c. Tennis (click here)
- Reminder was shared to communicate with tennis coaches to make sure to use UTR score as the UTR decided who plays at what position, not the coaches.
- 16. SDCC and SDUSD 2020-21 Fan Policy and Supervision for Indoor and Outdoor Sports

Clarity on SDCC and SDUSD bylaws and policies.

- a. SDCC fan and supervision policy (click here)
- Reminder was shared that the SDCC policy is still in play.
 - b. SDUSD observers district policy outdoor (click here)
- Remains the same.
 - c. SDUSD observers district policy indoor (this will be a live link by the time we meet)
- Shared that the Athletics Office is working with district leadership to update the policy.
 - d. Respect other schools policies for observers (click here)
- Reminder was shared to abide by and respect the home school's rules.
- Reminder was shared to communicate with the schools that are not in the same district and find out what the home team

policy is, then communicate with the school community.

17. SDCC 2020-21 Petco Park Games

Participant representation from SDCC is the same as 2019-20 since those games were cancelled.

- a. Mira Mesa vs. Patrick Henry and S. Ranch vs. Point Loma
- Information was shared that the schools were offered to play at Petco Park due to canceling last year.
- Reminder was shared that the game should be a league game, not add on.
- Reminder was shared to have coaches communicate with each other and ADs to coordinate.

- Information was shared that there will be individual meetings with each school's AD and admin to review your school data with SDUSD.
- Shared that the non-SDUSD will get the same information.

19. SDCC 2021-22 Leagues

Options and discussions Ron Lardizabal to provide an overview and review of multiple schedules discussions.

- Option 1: disregard all results of 2020-21 and leagues stay the same as 2019-20.
 - Note this is a COVID bylaw and will expire after 2021-22 season and will revert to the regular bylaws for leaguing for 2022-23.
- Option 2: utilize the results of this year as traditionally is done. Use coach recommendation for non-power ranked leagues and utilize the power rankings results for this year and re-league accordingly per those rankings.
 - This is our normal process with no change needed to any bylaws.
- Option 3: utilize the results of this year (power ranking and coach recommendations) and utilize a human element of a SDCC committee to adjust.
- If option 3 is chosen, SDCC needs to state if this is a COVID bylaw that is for 2021-22 or if this a permanent bylaw change that is being recommended.
- Moved to action item #23 for voting.
