# STUDENT BUS TRANSPORTATION

Bus transportation for district students is provided by Rustad Bus Service, Inc., and Riley Bus Service, Inc. Please contact them if questions arise concerning bus schedules or times. Questions concerning matters other than schedules or times are to be directed to the supervising principal of your child.

The school district's desire is to provide a trouble free and smooth operating bus service. However, in the past, there have been occasional incidents of improper student behavior. Cooperation, communications, and obeying bus rules are necessary to keep behavior problems to a minimum. If a child is referred to their principal because of improper behavior on a bus, the parents will be notified by phone and /or mail. Depending upon the severity and/or number of referrals, the child will be dealt with accordingly. If it becomes necessary, the child may not be allowed to ride a school operated vehicle until the parents, child and principal work out a satisfactory agreement.

### ATHLETIC and PARTICIPATION FEE INFORMATION

All athletes in grades 7-12 must have the following forms returned prior to practice or play in athletic programs:

### LUNCH PROGRAM INFORMATION

KMS Provides breakfast and lunch daily. KMS Participates in the USDA Federal Breakfast and Lunch program as well as the Minnesota Free School Meals for Kids Breakfast and Lunch program signed into law beginning July 1, 2023. Meals are provided at no cost for families. Milk break is available for grades 1-6 at a semester cost of \$30.00 or \$60.00 for full year. Kindergarten milk break is provided by the Minnesota Kindergarten milk program. Additional milk purchases alacarte are available at \$.30 cents per carton.

All meal purchases are to be prepaid before meal service begins. Families may add money to students' accounts by paying online with a debit or credit card on the KMS website school store, at the school high school, elementary or district offices or by mailing payment for their family meal account. Family account balances may not charge more than \$-25.00 on their accounts. Families will be notified of an outstanding negative balance once the negative balance reaches \$-25.00. Families will be notified by electronic email statements, mailed paper statements, text alerts or by phone.

Any student who is lactose intolerant will be provided with lactose reduced milk if they have a request from the parent.
