#### Built on premier competition, GHSA flag football is ascending

Flag football in the GHSA has grown tremendously since its introduction during the 2020 season. Every year, more and more schools are giving girls new opportunities to play in one of the fastest-growing sports in the state.

In the upcoming weeks, flag football will be a part of the Corky Kell + Dave Hunter 7-on-7 Tournament, with the event being held at West Forsyth. Flag football will also have its own Classic in October.

Playing its first season in 2020, flag football started out small. Due to it being a new sport during



Joe Burns among 30 named to Georgia High School Football Hall of Fame

ATLANTA — Former Thomas County Central running back Joe Burns was among 30 elected into the third Georgia High School Football Hall of Fame class announced this week.

A four-time Player of the Year on Associated Press and Atlanta Journal-Constitution All-State lists, Burns' Yellow Jackets teams went 29-1 and won two titles for Ed Pilcher his junior and senior seasons. Burns turned in 5,006 rushing yards for his high school days

the COVID-plagued 2020 season, only 87 schools fielded teams in two divisions with 43 schools in Division 1 and 44 schools in Division 2. In year one, West Forsyth won the first-ever Division 2 championship, defeating Hillgrove 26 to 25, while Calvary Day became the first team to win the Division 1 championship, defeating Portal 6 to 0.

In the sport's second year, flag football added nearly a hundred schools, getting up to schools while also adding a third The playoffs division. Southeast Bulloch beat Portal 20 to 0 to win the Division 1 championship. The Division 2 title was won by Dodge County, which beat Lithia Springs 6-0. Hillgrove avenged its championship loss, defeating Marietta 20 to 6, winning the first Division 3 championship.

In 2022, 41 schools joined the sport, pushing the number of schools competing in flag football up to 222. Southeast Bulloch became the first two-time champion, defeating Harris County 13 to 0 to claim its second Division 1 championship. Lithia Springs won the Division 2 title to get over the hump with its first championship after losing in the finals the year before, defeating Central Carroll 14 to 0. Blessed Trinity held off Milton 19

and an average yards per carry of 9.3. No slouch in other roles, he returned four kicks for touchdowns and had 68 total touchdowns.

At Georgia Tech, Burns was named first team All-ACC in 2001 and had 2,634 career rushing yards. Though undrafted, Burns played four NFL seasons with the Buffalo Bills

Other Southern Georgia players making the Class of 2024 are George Atkinson (Sol Johnson), Thomas Davis (Randolph-Clav). Lauren Hargrove (Fitzgerald), Tommy Hart (Ballard-Hudson), Len Hauss (Wayne County), Kent Hill (Americus), Leonard Pope (Americus). Demarvius Thomas (West Laurens) and Zambiasi (Mount de Ben Sales).

Valdosta State was the collegiate home of another selection, Jessie Tuggle.

An all-time great for the Atlanta Falcons, then-Valdosta State College signed Tuggle out of Griffin High for VSC's second ever season playing football. With the Blazers, Tuggle was named All-America as a senior. He was inducted into the Chickfil-A College Football Hall of

to 13 to win its first championship in Division 3.

Last season, another 24 schools joined the sport. With 246 schools competing in the sport, **Divisions** the grew unprecedented sizes with the biggest Division 2 having 92 members. These massive Divisions led to more competitive play and exciting playoffs. In Division 1, Southeast Bulloch cemented its dynasty and won its straight championship, third defeating North Oconee 14 to 0. In Division 2, Greenbrier stopped Lithia Springs' bid for a second straight title, winning 14 to 6. Pope won a nail-biter in the Division 3 championship, defeating Allatoona 14 to 13.

Fame in 2007. Tuggle's No. 88 is retired by VSU.

Undrafted out of Valdosta State, the Falcons signed Tuggle, where all he did was lead the NFL in total tackles four times and make five Pro Bowls. Tuggle played in Atlanta's first Super Bowl appearance. He was in the inaugural class of Atlanta's Ring of Honor.

Hargrove earned Wigwam Wiseman All-American in 1948 at Fitzgerald, scoring more than 60 touchdowns as a Purple Hurricane. Until recently, the 1948 team was the only football state champion in Fitzgerald history.

# Ga. AG Chris Carr files lawsuit against Title IX changes by Biden administration By WALB News



ATLANTA, Ga. (WALB) - Georgia Attorney General Chris Carr has filed a lawsuit, joining other state's attorneys general, to oppose aspects of the Biden administration's expansion of Title IX.

The expanded guidelines of Title IX offer measures to stop schools from banning transgender students and teachers from using restrooms that match their gender identities,

according to <u>NBC News.</u>. The Title IX rules also allow transgender athletes to compete in sports that fit their gender identity.

Those measures are part of the focus of Carr's lawsuit.

"The Biden administration is destroying women's sports by gutting commonsense provisions that protect female athletes and demanding that biological males be allowed to compete against females," Carr said in a statement. "Today we have taken action to defend women's rights to fair competition, and we will keep fighting until we end this absurdity once and for all."

Carr previously pushed back against Biden's administration updates to Title IX in 2022.

Three other attorneys general are also a part of the lawsuit including those from Alabama, Florida and South Carolina.

### Unacceptable Behavior at High School Sporting Events – It's Still Happening By Dr. Karissa Nihoff, NHSF.org



Unacceptable behavior at high school sporting events – it's still happening. And much of this deplorable behavior continues to be directed at the thousands of individuals who VOLUNTEER to serve as contest officials.

While many states have reported an increase in the number of individuals signing up to officiate high school sports – particularly in the past few years of recovery from the

pandemic – surviving the constant questioning of calls, name-calling, profane language and even violent attacks remains a challenge for new officials.

This is supposed to be EDUCATION-BASED SPORTS. Yet, the NFHS has heard reports of coaches – and even student-athletes themselves – disrespecting officials on the court and field.

We have to do better. We must do better. As the slogan for our Bench Bad Behavior campaign says, Enough is Enough.

One of our sport directors attended a state basketball tournament a few weeks ago. The games were action-packed, the skill level was superb, the stands were packed. Two outstanding teams advanced to the championship game. The

tournament was a great success – except for the behavior. In high school sports, however, that is an unacceptable exception. Coaches and players in the final game were constantly on the officials, questioning calls. Does winning, in and of itself, define success in high school sports? The answer should be a resounding NO!

Since the NFHS started its Become an Official campaign about seven years ago, more than 125,000 people have applied to become a high school official. These are individuals who had a desire to give up time on weeknights and weekends – for not much money – so that millions of high school students could be involved in sports.

These individuals officiate to give back to high school athletics. Do they get every call right every night? Absolutely not, just like coaches and student-athletes make mistakes at times.

High school sports need to be different than the college and professional levels, where players and coaches tend to complain about almost every call. High school sports are also different than non-school youth travel teams, where the emphasis is on individual accomplishments and winning. While we wish the behavior of coaches and athletes at other levels presented a better role model, behavior in education-based high school sports must be different.

## Leadership Spotlight: Sarah Bridenbaugh, KHSAA Assistant Commissioner NFHS.org

Age is just a number. KHSAA Assistant Commissioner Sarah (Van Horn) Bridenbaugh is proof of that. In the opposite direction of what most people think when hearing this phrase, she never lets her young age stop her from being the leader she was destined to be.



Early in her high school career, her coaches recognized her skills and leadership abilities, placing heavy responsibilities on her shoulders to guide the team through a difficult division. She rose to the occasion, getting her first varsity minutes in the postseason as a freshman. From there, she was a presence on the floor for Morgan High School and earned allstate honors in her junior and senior seasons.

Bridenbaugh garnered the attention of several colleges, including West Virginia Wesleyan College, where she signed and shined.

In her freshman season, she was named to the All-WVIAC Freshman Team and was First Team All-WVIAC the remaining three seasons. In her senior season, she was WVIAC Player of the Year.

She averaged 20 points and more than 10 rebounds per game for her career. Bridenbaugh graduated as the all-time leading scorer for WVWC with 2,087 points, was a finalist for the State Farm All-American team and was a two-time Honorable Mention on the NCAA II All-American team. These accomplishments made her a natural selection for the 2023 WVWC Hall of Fame Class, barely 15 years removed from her playing days.

At 24, she was tabbed as Paul Laurence Dunbar's girls' basketball head coach (Kentucky), after starting her career coaching two seasons at Lewis County, WV. At Paul Laurence Dunbar, she guided the Lady Bulldogs to the KHSAA Girls' Sweet 16® semifinals and compiled a four-year record of 92-37. She was hired by KHSAA as assistant commissioner in August of 2015.

In her ninth year, she is currently the lead contact for six championships – cross country, competitive cheer, dance, swimming and diving, and outdoor track and field – and was the lead in starting the first-ever indoor track and field state championships.
